### **Collection of Covid-19 Vaccination Records**

Dear parents :

The school will be arranging for students to return to school during the afternoons for activities. However, the Education Bureau's guidelines for returning to school in the afternoon stipulate that, vaccination records must be collected. For students who have received two doses of vaccine more than 14 days before 1<sup>st</sup> October 2022, schools may allow them to stay at school after lessons or for half-days for non-academic extra-curricular activities.

To further strengthen the protective barrier of schools, starting from 1<sup>st</sup> October 2022, related requirements will be stepped up. Students will be required to have received three doses of vaccine. These above arrangements do not apply to students aged 5 to 11 years who are required to receive only two doses of BioNTech vaccine, and students with prior COVID-19 infection, who are not required to take the third dose of vaccine.

Students who have received two doses of vaccine but are still within the time interval waiting to receive the third dose should, by following the CHP's recommendation, receive the third dose of vaccine within one week of being eligible to do so. Please note :

- (1) If your child has received the vaccine, please submit their vaccination record (copy) to their class teacher on or before 9<sup>th</sup> September.
- (2) If you have already submitted your child's vaccination record (copy) to the school, you do not need to submit it again.

(3) If your child will be vaccinated at a later time, please submit the latest vaccination record (copy) to their class teacher as soon as possible.
